The 10th Annual General Body meeting was held on 29.11.2020 - Sunday - at 10.30 am via virtual mode. 73 Life members participated.

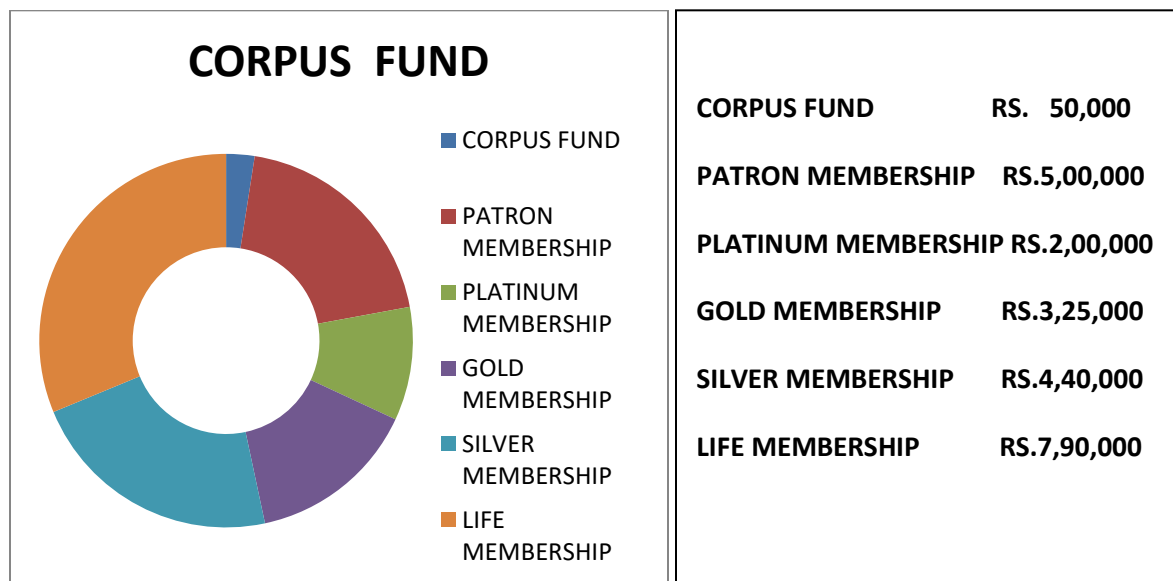
AUDITORS:
