**ORIGIN:**

The Commerce 1992-95 batch meet held at NMSSVN College on 25.07.2010. In that meeting the idea of forming the NMSSVN College Commerce Graduates trust was mooted by Prof Dr. K.Natarajan and acknowledged by the College Secretary Perrys P.Mahendrael and Prof.V.Thilagarajan. To give shape for that idea, on 29.08.2010 at our College, a Commerce Alumni Consultation meeting was organized. Large number of Commerce Alumnis from various batches participated. In that meeting the idea for forming the Commerce Graduates Trust was discussed. All the participants welcomed the move and offered their whole hearted support for that idea. In that meeting itself an adhoc committee was formed to discuss the modalities for forming the TRUST. The adhoc committee met for 3 times and discussed the draft trust deed and finalized the trust deed by name “ NADAR MAHAJANA SANGAM S.VELLAICHAMI NADAR COLLEGE COMMERCE ALUMNAE TRUST ”. In short it was named as “SVN-COMAT”.
