# **ACTIVITY REPORT-2016-17**

# ORIGIN:

The Commerce 1992-95 batch meet held at NMSSVN College on 25.07.2010. In that meeting the idea of forming the NMSSVN College Commerce Graduates trust was mooted by Prof Dr. K.Natarajan and acknowledged by the then College Secretary Perrys P.Mahendravel and Prof.V.Thilagarajan. To give shape for that idea, on 29.08.2010 at our College, a Commerce Alumni Consultation meeting was organized. Large number of Commerce Alumnis from various batches participated. In that meeting the idea for forming the Commerce Graduates Trust was discussed. All the participants welcomed the move and offered their whole hearted support for that idea. In that meeting itself an adhoc committee was formed to discuss the modalities for forming the TRUST. The adhoc committee met for 3 times and discussed the draft trust deed and finalized the trust deed by name "NADAR MAHAJANA SANGAM S.VELLAICHAMI NADAR COLLEGE COMMERCE ALUMNAE TRUST". In short it was named as "SVN-COMAT". Accordingly, as decided, the Trust was formed and registered on 30.12.2010.

As decided in the III AGM held on 11.08.2013, the name of the Trust was modified as "NADAR MAHAJANA SANGAM S.VELLAICHAMY NADAR COLLEGE COMMERCE ALUMNI TRUST.

# LIFE MEMBERSHIP:-

As per our Constitution, only Commerce Alumni of NMSSVN College can become life member by paying Rs.1,000/- as life membership subscription.

# PATRON MEMBERSHIP:

Any life member contributing a sum of Rs.1,00,000/- and above shall be called as PATRON MEMBER.

# **DIAMOND MEMBER:**

Any life member contributing a sum of Rs.75,000/- and above shall be called as DIAMOND MEMBER.

#### PLATINUM MEMBER:

Any life member contributing a sum of Rs.50,000/- and above shall be called as PLATINUM MEMBER.

#### GOLD MEMBER:

Any life member contributing a sum of Rs.25,000/- and above shall be called as GOLD MEMBER.

#### SILVER MEMBER:

Any life member contributing a sum of Rs.10,000/- and above shall be called as SILVER MEMBER.

The above contributions can be made progressively.

CA G.Selvakumar FCA has been appointed as honorary auditor of SVN COMAT. SVN-COMAT thanked the previous auditor Dr. CA.Thavamani for auditing the accounts as honorary auditor for 6 years.
