As decided in the III AGM held on 11.08.2013, the name of the Trust was modified as " NADAR MAHAJANA SANGAM S.VELLAICHAMY NADAR COLLEGE COMMERCE ALUMNI TRUST.

Any life member contributing a sum of Rs.25,000/- and above shall be called as GOLD MEMBER.

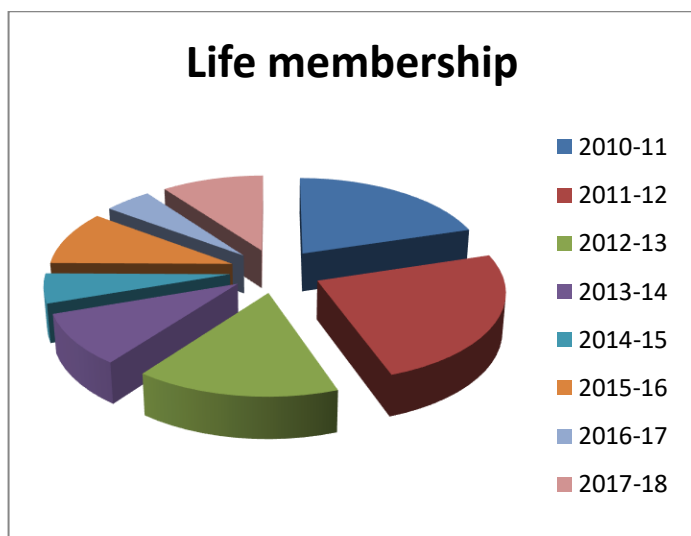
SILVER MEMBER:

ASSOCIATE MEMBERSHIP:

A new concept of Associate membership has been introduced. The present B.Com students of our College can become an Associate member with a minimum contribution of Rs.250/-. EDUCATIONAL ASSISTANCE:

1. During the year, SVN COMAT has paid the examination fee of Rs.46,050/- to 74 deserving Students for the 5th and 6th Semester identified and recommended by our college.
2. Educational Assistance of Rs.10,000/- provided to Ms. T.Vyshali, daughter of our member Late Thillaichidambaram of 1992-95 batch for doing BE Course. (She has completed BE and joined employment in Infosys, Chennai).
3. Educational assistance of Rs.6000/- paid to 2 children of Late Mr. Rajakani of 1989-92 batch for remitting school fees.

STUDENTS DEVELOPMENT PROGRAMME:

This year your SVN COMAT conducted a course on " Effective Communication in English" for our college students. 40 Students from various Courses participated.

Another Leadership Development Programme was conducted for the benefit of our college students. 45 students from various courses participated.

For both the programmes the feedback from the students is good and they requested more such programmes.

Apart from the above, our members addressed our B.Com students on career guidance meetings.

MEMERSHIP CARD:

Membership Cards and life membership certificate were issued to all members. Those who have lost/misplaced/destroyed the card can get new card on payment of Rs.100/-.

BOARD MEETINGS:

During the year apart from the VIIth AGM held on 06.08.2017, 5 Trust Board meetings and one executive committee held for effective administration. The meeting expenses were sponsored by our Board members.

VIIth ANNUAL GENERAL BODY MEETING:

The VIIth Annual General Body meeting held on 06.08.2017. About 200 Life members participated. A kit sponsored by our members were distributed to all the members who attended the AGM. Out of the AGM Lunch expenses of Rs. 26,070/-, Rs.27,000/- was sponsored by our members.

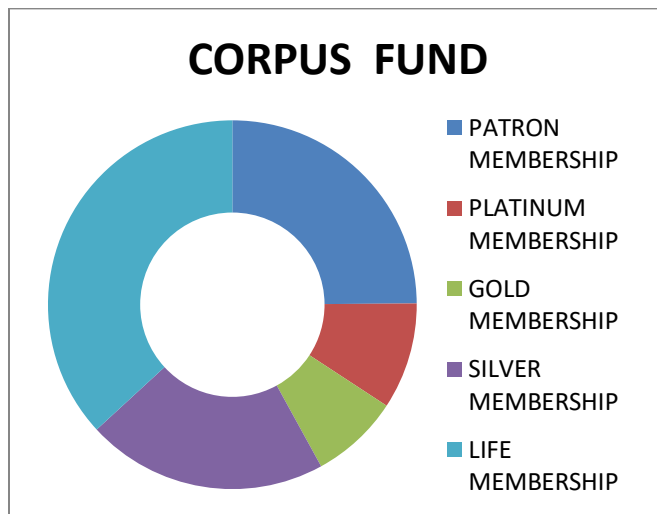
REGISTRATION U/S 12AA OF THE INCOME TAX ACT,1961.
